- **Generations** is a one-time add-on that provides additional generations without extending the subscription period.
- **Prolongate** extends the validity period of an active Premium subscription by 30 days without adding generations.
- All payments are final and non-refundable, except as required by applicable law.
- We use third-party payment processors and do not store full payment card details.
